

What is Grow Your Own?

- Partnerships between early educator preparation/professional development programs, early care and education programs, and/or other community organizations
- Recruit educators from within community
- Might provide stipends, scholarships, and unique student placement experiences



Why Grow Your Own



- Shortage of educators in all program types
- Educators need specific knowledge and skills to support children and families
- Parents cannot find program for children disrupts their work and family ability to thrive
- Cost of education and professional development are a barrier
- Cost for staff turnover
- Inconsistent care and education for children being served

What are the Benefits?

- Strengthen ties in the community
- Reduces recruitment cost Allocated to other supports
- Advance career pathways Attract new talent and elevate existing staff
- Contribute to the overall wellbeing of staff, children, and families being served!

How is it Funded?

- The need to support interested individuals in obtaining credentials and degree needs for entering or advancing in the early childhood workforce was heard by the 2023 legislation and the Grow Your Own Early Childhood and Family Educator Program was funded
- Funding is made available through <u>Laws of Minnesota 2023, chapter 54,</u> <u>section 6</u>
- This grant opportunity estimates that \$2,325,000 is available to fund 15-20 grants during Fiscal Year 2025. The maximum grant award may not exceed \$200,000.

Who can Submit a Proposal?

Eligible applicants include:

- Minnesota-licensed family child care or licensed center-based child care programs
- School district or charter school early learning programs, including Early Childhood Special Education, Early Childhood Family Education, School Readiness, and Voluntary PreK
- Head Start programs, including Tribal Head Start and Early Head Start
- Institutions of higher education
- Community partnership nongovernmental organizations

Examples

- Providing scholarships or stipends to participants pursuing early childhood degrees and credentials for example, a Birth to Third Grade teacher license, Early Childhood Special Education teacher license, or Parent Education teacher license from a <u>Professional Educator Licensing and Standards Board</u> (PELSB) -approved teacher preparation program, a bachelor's degree in early childhood education, an associate's degree in early childhood education or child development, or a Child Development Associate (CDA) or other early childhood credential.
- Providing programming and support for teacher candidates to help them be successful in the licensure program, degree program, or the credential program.

Timeline

- Questions must be emailed to the program contact by September 27, 2024
- A question-and-answer document will be published on the grant opportunity site after October 2, 2024
- Applications due: October 18, 2024 by 5 p.m. Central Time
- Applicants notified of funding decisions: Late November
- Anticipated grant start date: January 1, 2025
- Grant end date options: June 30 of 2025, 2026, 2027 or 2028

A complete application submission will include Application Coversheet, Assurances, Application Narrative and Excel Budget, along with any other documentation that is requested in the Instruction Document. We request that application materials are submitted in English. Submitting in a language other than English may delay the review process.

- Email complete applications to mde.compgrants@state.mn.us
- Include one copy of the signed application coversheet, assurances, and application narrative in one document (in PDF format) and one copy of the completed budget (in Excel format) to mde.compgrants@state.mn.us with the subject line GYO Early Childhood Educators Grant, then the name of your organization. You should title all documents with the name of your organization, then the name of the document.
- We will not accept applications via fax, through the SERVS system, or saved as Google docs.
