Minnesota tau ib qho nyiaj pab kawm ntawv tshiab rau Preschool Development Grant

Minnesota tau txais txiaj ntsig \$24 lab nyiaj pab los ntawm tsoomfwv, cov nyiaj pab tom ntej [Preschool Development Grant \(PDG\)](#). Cov nyiaj pab no muab \$8 lab txhua xyoo txog lub Cuaj Hli 2027 thiab yuav txuas ntxiv lub xeev txoj haujlwm sib koom tes los txhawb cov menyuam yaus thiab tsev neeg. Pab pawg PDG hauv xeev tau zoo siab rau lub sijhawm uas qhov nyiaj pab no yuav muab rau Minnesota!

Tus Nqi Se Me Nyuam yog dab tsi?

[Tus Nqi Se Me Nyuam](#) muaj rau cov nyob hau Minnesota uas muaj menyuam yaus hnub nyoog qis dua 18 xyoo. Yog ua Minnesota daim them se, koj tsim nyog tau txais \$1,750 rau ib tus menyuam tsim nyog uas tsis muaj kev txwv rau cov menyuam yaus. Cov credit yuav maj mam txo yog tias koj cov nyiaj tau los ntau dua \$31,090 (\$36,880 rau Cov Sib Yuav Ua Haujlwm Sib Koom).

Lub caij ntuj sov no, daim ntawv tso cai saib xyuas menyuum yaus thiab ntawv pov thawj yuav tsiv tawm ntawm Lub Tsev Haujlwm Saib Xyuas Tib Neeg (DHS) mus rau Lub Tsev Haujlwm Saib Xyuas Menyuum Yaus, Hluas, thiab Tsev Neeg (DCYF). Cov qauv ntawv tso cai thiab ntawv pov thawj tam sim no muaj nyob hauv Minnesota Tsab Niam Cai, tshooj 245A thiab tshooj 245H, yuav tsiv mus rau Minnesota Tsab Niam Cai tshiab tshooj 142B (ntawv tso cai) thiab 142C (ntawv pov thawj). Qhov yuav tsum tau muaj nyob hauv Minnesota Cov Cai yuav tsis txav mus. Cov chaw tsim cai tshiab yuav siv tau tom qab hloov mus rau DCYF (xav tias lub Rau Hli 2025).
