 - RFP Tasks: Provide culturally responsive, relationship-based service navigation to make it easier for families to get what they need and build strengths, develop and support a new or existing parent and family advisory council consisting of community members with lived expertise to advise the work of the grantee, provide peer networking and support activities, demonstrate community-based planning with multiple local partners and sustain partnerships between organizations and families to build capacity and support seamless service availability across the range of protective factors, support community engagement and feedback gathering to support program planning and continuous improvement to promote protective factors
 - Visioning: Responsive to community needs/community voice: Acknowledges both what communities have and what they need, holistic safety, trust, and belonging, ease of



access (to services), needs met: Connection and removing barriers, financial sustainability, partnerships and supportive civic infrastructure, quality and continuous improvement

- E. Question: A logic model says 'If x, then y", so if practical vision a, b, c, etc, then the practical vision is achieved. Does anything need to be added or changed in order for the logic model to be... logical?
 - Responses
 - i. I don't see anything within the categories that highlight financial stability.
 - ii. There isn't an outcome that would lead up to the financial stability piece.
 - iii. What does social determinants of health mean from a system's perspectivedoes that mean resources to promote SDH
 - iv. I think that family connectedness is important to become stable, if they were previously unstable. I think that it was important to keep my children with me and not have them in foster care.
 - v. Do we need to address fiscal sustainability and quality/continuous improvement?
 - vi. We know how SDoH need to be promoted, but if there aren't any services behind it, then what are we talking about?
 - vii. If services that families need don't exist where they live, they can't even be referred to needed services.
 - viii. Is this the only group at the State looking at these systems building processes around Social Determinants of Health and also accessing resources?
