Early Childhood Indicators of Progress (ECIPs) yog qhov qauv kawm ntawv rau cov me nyuam yau hauv Minnesota, uas qhia txog qhov kev cia siab rau yam uas cov me nyuam yau (txij hnuv yug txog 5 xyoo) yuav tsum paub thiab ua tau raws li lawv txoj kev loj hlob.

Qhov kev hloov kho ntawm qhov Early Childhood Indicators of Progress yog los xyuas kom cov qauv tseem haum rau kev siv, raws kev tshawb fawb, thiab suav txhij rau txhua tus me nyuam hauv Minnesota. Cov hom phiaj tseem ceeb ntawm txoj kev hloov kho no muaj xws li:

- Ntxiv cov kev tshawb fawb tshiab txog me nyuam kev loj hlob kom phim rau cov kev coj ua zoo tshaj plaws tam sim no

Lub rooj sib tham los tswj cai nyob rau xyoo 2025 tau xaus rau hnuv tim 19 lub Tsib Hlis 2025, thiab muaj ib qho rooj sib tham tshwj xeeb ntxiv nyob rau Lub Rau Hli los ua kom tiav tej hauj lwm uas tseem ua tsis tau tiav. Cov

lus tshaj tawm tshiab no tau muaj xa mus rau cov neeg zov me nyuam hauv tsev thiab cov chaw zov me nyuam uas muaj daim ntawv tso cai, nrog ib qho kev piav luv txog kev hloov ntawm kev tso cai. Cov lus piav qhia txog cov kev hloov no mam muaj qhia tawm rau lwm lub sij hawm. Cov chaw zov me nyuam uas tau daim ntawv pov thawj twb tau txais ib daim ntawv qhia uas qhia meej txog tej kev hloov uas yuav cuam tshuam rau lawv cov programs.
