About the Directory

The Minnesota Restorative Services Directory is a free resource, updated annually. It is designed to connect people who provide restorative services with those seeking them.

In 2023 and 2024, the Minnesota Department of Corrections (DOC) produced this directory. In December 2024, the Department of Public Safety, which housed the newly created Office of Restorative Practices (ORP), contracted with the University of Minnesota's Liberation Lab to produce this 2025 directory as part of a larger project to assess the state of restorative practices in Minnesota. The DPS, DOC, and Liberation Lab do not endorse any person or program listed in this directory. This directory is voluntary to participate in and does not reflect the entirety of restorative services offerings across the state.

Terms & Working Definitions

Restorative justice: A way of thinking about and responding to harm in communities and institutions that emphasizes accountability and repair over punishment and retribution.

Criminal legal sector: law enforcement, lawyers (prosecution, defense), probation, courts, county jails, state prisons, parole/community supervision

Local government sector: human services, public health, social services

Education sector: early childhood, public K-12, and adult basic education system (B-12+)

Higher Ed sector: Colleges and universities

Workplaces: non-profits, for-profits, private sector

Scope

This directory includes information about restorative services offered across a wide range of applications and populations. Services include direct facilitation among impacted parties, training, coaching, and practice-based expertise.

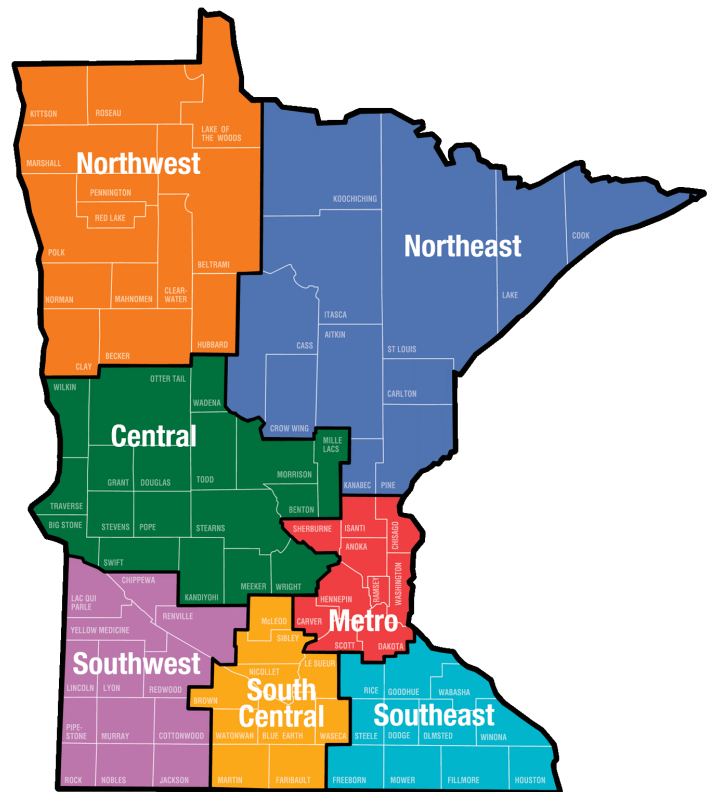
