

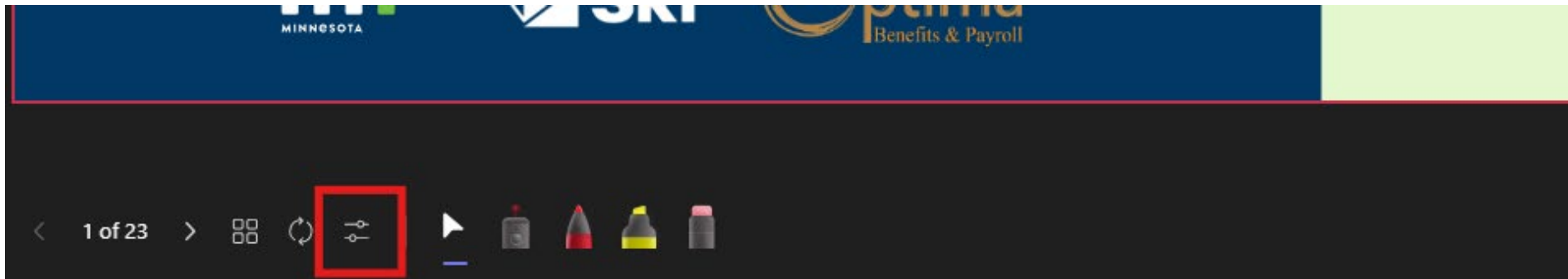

Vim Li Cas Minnesota Thiaj Muaj Qhov Kev Pab Cuam No?

- Cov kws qhia me nyuam thaum ntxov muaj lub luag hauj lwm tseem ceeb los txhawb cov me nyuam thiab cov tsev neeg.
- Muaj coob tus kws qhia me nyuam thaum ntxov tsis muaj kev nkag tau rau cov kev pab uas lawv xav tau.
- Cov kev pab no yuav kim heev los sis nyuaj rau kev nkag tau, tshwj xeeb yog rau cov neeg ua hauj lwm hauv cov program me.
- Minnesota tab tom nrhiav txoj hauv kev tshiab los pab cov kws qhia me nyuam thaum ntxov kom tau txais cov kev pab uas txhawb lawv txoj kev noj qab haus huv, kev noj qab nyob zoo, thiab kev ruaj ntseg rau nyiaj txiag.

58% ntawm cov neeg uas yav tas los ua lag luam zov me nyuam hauv tsev hais tias qhov tsis muaj cov kev pab yog ib qho laj thawj uas ua rau lawv txiav txim siab kaw lawv lub lag luam.

Qhov Kev Pab Cuam No Yog Dab Tsi?

Minnesota Early Educator Benefits Program tuaj yeem muab kev pab rau kwv yees li **800 txog 1,000 tus kws qhia me nyuam thaum ntxov uas muaj feem tsim nyog nyob thoob plaws lub xeev Minnesota.**

Los ntawm qhov kev pab cuam no, Minnesota tab tom:

- Muab ntau hom kev pab uas cov kws qhia me nyuam thaum ntxov uas muaj feem tsim nyog yuav xaiv tau.
- Kawm seb hom kev pab twg thiaj li haum zoo tshaj plaws raws li cov kev xav tau ntawm cov kws qhia me nyuam thaum ntxov.
- Kawm seb yuav tsum ua li cas thiaj li muab tau cov kev pab ncaj qha rau cov kws qhia me nyuam thaum ntxov.
- Siv yam uas tau kawm los pab txhawb kev txiav txim rau yav tom ntej txog cov kev pab thiab kev txhawb nqa rau cov neeg ua hauj lwm.

Cov Neeg Koom Yuav Muaj Feem Tau Txais Dab Tsi?

Yog raug xaiv, cov neeg koom tuaj yeem:

- Tau txais nyiaj mus txog \$55 tauj ib lub hlis los pab them rau cov kev pab uas tsim nyog
- Xaiv cov kev pab uas haum tshaj rau lawv thiab lawv tsev neeg cov kev xav tau
- Cuv npe rau cov kev pab uas tsis khi rau ib tug tswv hauj lwm twg
- Xaiv tau ntau hom kev pab, xws li:
 - Kev noj qab haus huv thiab kev noj qab nyob zoo (piv txwv li, telehealth, kev kuaj qhov muag, thiab kev kho hniav)
 - Kev tiv thaiv nyiaj txiag (piv txwv li, kev pov hwm kev tsis taus (disability) thiab kev pov hwm xwm txheej raug mob(accident))
 - Kev pab thaum muaj xwm txheej hauv lub neej (piv txwv li, kev pab txog kev cai lij choj)
- Qhov kev pab cuam no tsis yog kev pov hwm kev kho mob uas them tag nrho cov nqi kho mob. Nws yog tsim los ntxiv rau koj qhov kev pov hwm uas twb muaj lawm thiab pab txhawb koj txoj kev noj qab haus huv thiab kev noj qab nyob zoo.

- Pab cov neeg koom cuv npe rau cov kev pab
- Teb cov lus nug txog cov kev pab uas muaj
- Saib xyuas thiab tswj cov kev pab thoob plaws lub sij hawm ntawm qhov kev pab cuam no

Cov Kev Pab Cuam Uas Muaj Rau Kev Noj Qab Haus Huv thiab Kev Noj Qab Nyob Zoo

Cov kev pab no pab saib xyuas koj txoj kev noj qab haus huv ntawm lub cev, kev puas siab puas ntsws, thiab pab tiv thaiv kev mob ua ntej.

Life Insurance

Koj tsev neeg yuav tau txais nyiaj thaum koj tas sim neej.

Short-Term and Long-Term Disability

Kev them nyiaj hli yog tias koj ua hauj lwm tsis tau vim muaj mob los sis raug mob uas yuav tau nyob ib ntus los sis ntev.

Accident Insurance

Muab nyiaj them rau tej kev raug mob los ntawm xwm txheej uas tsim nyog, nrog rau lwm yam kev kho mob uas cuam tshuam rau qhov raug mob ntawd.

Hospital Indemnity

Critical Illness

Muaj nyiaj them yog tias kws kho mob kuaj pom tias koj muaj ib yam mob uas mob hnyav uas tsim nyog tau txais kev pab.

Legal Services

- Lub sij hawm thov yuav pib rau Hnub Tim 6 Lub Xya Hlis thaum 8 moos sawv ntxov Central Time.
- Kev ua tiav daim ntawv thov yuav siv li 5 mus txog 10 nas this.
- **Npaj cov ntaub ntawv hauv qab no ua ntej:**
 - Koj cov ntaub ntawv tiv tauj
 - Cov ntaub ntawv txog qhov chaw koj ua hauj lwm los sis lub program uas tsim nyog
 - Koj lub sij hawm ua hauj lwm
 - Tsawg kawg ob daim tw tshev tsis ntev los no. (Tsis siv rau cov tswv ntawm cov chaw zov me nyuam hauv tsev)
- Xyuas cov email uas xa tuaj los ntawm Christen Park ntawm SRI txog koj daim ntawv thov. Nco ntsoov xyuas koj qhov ntu spam/junk thiab.
- Yog tias kev txais neeg twb puv lawm, peb yuav muab koj lub npe tso rau hauv daim ntawv teev npe tos. Yog muaj chaw seem los sis qhov kev pab cuam no tau txais nyiaj ntxiv, peb mam li hu koj.

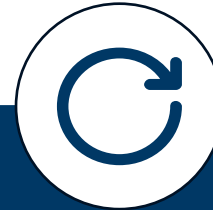
